ABEL AN ATTORNEY AT LAW PRACTICING BEFORE THIS COURT, WAS THE ATTORNEY SO APPOINTED, AND

THE COURT BEING FULLY ADVISED IN THE PREMISES IT IS NOW, UPON MOTION OF THE PLAINTIFF,

ORDERED, ADJUDGED AND DECREED THAT THE BONDS OF MATRIMONY HERETOFORE AND NOW EXISTING BETWEEN THE PLAINTIFF L. E. BLACK AND THE DEFENDANT SUSIE AMELIA BLACK BE, AND THE SAME ARE HEREBY DISSOLVED; THAT THE PLAINTIFF AND DEFENDANT AND EACH OF THEM ARE HEREBY FREED FROM ANY AND ALL OF THE OBLIGATIONS ARISING BY VIRTUE OF THE MARRIAGE RELATION; AND THAT SAID PLAINTIFF AND DEFENDANT ARE EACH RESTORED TO THE STATUS OF SINGLE PERSONS; THAT THE PLAINTIFF HEREIN BE, AND HE IS HEREBY GRANTED A DECREE OF ABSOLUTE DIVORCE FROM THE DEFENDANT..

IT IS FURTHER ORDERED, ADJUDGED AND DECREED THAT THE PLAINTIFF, L. E. BLACK BE AND HE IS HEREBY AWARD THE SOLE CARE, CUSTODY, MANAGEMENT, EDUCATION AND REARING OF THE TWO MINOR CHILDREN OF THE PLAINTIFF AND DEFENDANT OTIS BLACK AND ALDEN BLACK.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED THAT THE PLAINTIFF BE AND HE IS HEREBY DECREED TO BE THE SOLE OWNER OF THE FOLLOWING DESCRIBED REAL ESTATE, TO-WIT:

(PROPERTY IN LEWIS COUNTY, WASHINGTON)

ALSO THE SOUTHEAST QUARTER OF SECTION 11, TOWNSHIP 3, NORTH RANGE SIX EAST OF W.M. SKAMANIA COUNTY, WASHINGTON, CONTAINING 160 ACRES MORE OR LESS.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED THAT NEITHER THE PLAINTIFF NOR THE DEFENDANT HEREIN SHALL CONTRACT ANY MARRIAGE WITH ANY THIRD PARTY FOR THE PERIOD OF SIX MONTHS FROM THE DATE OF THE ENTRY OF THIS ^{DECREE OF} DIVORCE, AS PROVIDED BY THE LAWS AND STATUTES OF THE STATE OF WASHINGTON.
