OLSEN, PARTY OF THE FIRST PART, FOR AND IN CONSIDERATION OF THE SUM OF TEN (\$10.00) DOLLARS IN LAWFUL MONEY OF THE UNITED STATES OF AMERICA, TO HER IN HAND PAID BY HEINRICH KAPP, PARTY OF THE SECOND PART. HAS GRANTED, BARGAINED AND SOLD AND BY THESE PRESENTS DOES GRANT, BARGAIN, SELL AND CONVEY UNTO THE SAID PARTY OF THE SECOND PART, AND TO HIS HEIRS AND ASSIGNS, THE FOLLOWING REAL PROPERTY, SITUATE, LYING AND BEING IN THE COUNTY OF SKAMANIA, STATE OF WASHINGTON, TO-WIT:

ALL OF LOT NINETEEN (19) OF BLOCK ONE (1) OF THE FIRST ADDITION TO THE Town of Underwood, Skamania County, Washington, according to the official plat now ON FILE AND OF RECORD IN THE OFFICE OF THE AUDITOR OF SAID COUNTY; IT BEING THE INTENTION OF GRANTOR HEREIN TO CONVEY TO GRANTEE ALL THAT PORTION OF SAID LOT NINETEEN (19) NOT HERETOFORE CONVEYED TO GRANTEE BY WARRANTY DEED DATED ON OR ABOUT JULY 30TH, 1921.

EXECUTORS AND ADMINISTRATORS, DOES HEREBY COVENANT TO AND WITH THE SAID PARTY OF THE SECOND PART, HIS HEIRS AND ASSIGNS, THAT SHE IS THE OWNER IN FEE SIMPLE OF SAID PREMISES AND THAT THEY ARE FREE FROM ALL ENCUMBRANCE AND THAT SAID PROPERTY IS HER SOLE AND SEPARATE PROPERTY AND ESTATE AND THAT SHE WILL WARRANT AND DEFEND THE TITLE THERETO AGAINST ALL LAWFUL CLAIMS WHATSOEVER.
