(j) Beginning at the electric substation of the Company in the City of Pendleton, in Umatilla County, Oregon; thence in a northeasterly direction through the towns or cities of Adams, Athens and Freewater, in said Umatilla County, to the electric substation of the Company in the City of Walla Walla, in Walla Walla County, Washington;

(k) Beginning at the electric substation of the Company in the City of Freewater, in Umatilla County, Oregon; thence in a southeasterly direction to the power house of the Company situated in Section Twenty-six (26), Township Five (5) North, Range Thirty-six (36) East, Willamette Meridian, in said Umatilla County;
