FARM MORTGAGE.

THIS MORTGAGE, Made this 1st day of March, 1935, by Rennie L. Blake, who was at the time he acquired title to the property herein described, and now is, a single man, of Washougal in the County of Clark, State of Washington, mortgagors, to the Land Bank Commissioner, acting pursuant to Part 3 of the Act of Congress known as the Emergency Farm Mortgage Act of 1933, at his office and place of business in the City of Spokane, State of Washington, mortgagee,

Witnesseth: That in consideration of a loan to the mortgagors, evidenced as hereinafter described, the mortgagors hereby mortgage to the mortgagee the following described real property situated in the County of Skamania, State of Washington, to-wit: Co

The East Half of the Southeast Quarter and the Southwest Quarter of the Southeast Quarter of Section Seven, Township One North, Range Five, East of the Willamette Meridian.

Except the following described tract: Beginning at the Southeast Corner of Section Seven, Township One North, Range Five, East of the Willamette Meridian, thence North 18 rods, thence West 92 Rods, more or less, to the East brink of the Canyon thereon, thence Southwesterly along the East brink of said Canyon to the South line of said Section Seven, thence East on the South line of said Section to place of beginning, containing 10½ acres more or less, deeded to B. Jemtegaard.

All the West Half of the Southwest Quarter of the Southwest Quarter of Section Eight, Township One North, Range Five, East of the Willamette Meridian.

Subject to agreement with B. Jemtegaard to use strip on South side of this tract for road purposes and certain water rights as recorded in Book "P" of Deeds at page 80, records of Skamania County, Washington,

together with all the tenements, hereditaments, rights, privileges and appurtenances, now or hereafter belonging to or used in connection with the above described premises; and all plumbing, lighting, heating, cooking, cooling, ventilating, elevating, watering and irrigating apparatus and fixtures, now or hereafter belonging to or used in connection with the above described premises; and together with all waters and water rights of every kind and description and however evidenced or manifested, which now or hereafter may be appurtenant to said premises or any part thereof, or incident to the ownership thereof, or any part thereof, or used in connection therewith; and together with all of the rents, issues and profits of the mortgaged property.
