The northeast quarter of southwest quarter and northwest of southeast quarter of section 18, township 2 north, range 5 East of the Willamette Meridian, containing 80 acres.

This mortgage is given to secure the payment of the sum of Five Hundred Dollars together with interest thereon at the rate of six per cent per annum, payable semi-annually, in accordance with the terms and conditions of a certain promissory note bearing even date herewith and due August 2, 1936.

Also to pay all taxes and assessments levied against said property before the same become delinquent. In case of failure so to do the mortgagees may pay said taxes and assessments, and all sums of money advanced for said purposes shall bear ten percent interest until repaid and shall be secured by the lien of this mortgage. In case of failure of mortgagors to make any payment, or keep any covenant contained in said note or this mortgage, the whole shall become immediately due and collectible at the option of the mortgagees.
