WHEREFORE, BY REASON OF THE LAW AND THE PREMISES AFORESAID, IT IS ORDERED, ADJUDGED, AND DECREED THAT C. R. ZENER, PLAINTIFF, DO HAVE AND RECOVER OF AND FROM THE SAID DEFENDANTS R. A. MILLER AND RUTH MILLER, HIS WIFE, THE SUM OF \$71.95, UNITED STATES LAWFUL MONEY, WITH INTEREST THEREON AT THE RATE OF 6 PER CENT PER ANNUM FROM THE DATE HEREOF UNTIL PAID; TOGETHER WITH SAID PLAINTIFF'S COSTS AND DISBURSEMENTS INCURRED IN SAID ACTION, AMOUNTING TO THE SUM OF \$6.40.

AND IT IS FURTHER ORDERED, ADJUDGED, AND DECREED, THAT SAID PLAINTIFF DO HAVE EXECUTION AGAINST THE COMMUNITY PROPERTY OF BOTH DEFENDANTS AND AGAINST THE SEPARATE PROPERTY OF EACH OF THEM.

THIS INDENTURE WITNESSETH, THAT R. F. BROWN, PARTY OF THE FIRST PART, FOR AND IN CONSIDERATION OF THE SUM OF TEN DOLLARS AND OTHER VALUABLE CONSIDERATION, LAWFUL MONEY OF THE UNITED STATES OF AMERICA, TO HIM IN HAND PAID BY C. O. NELSON PARTY OF THE SECOND PART, DOES BY THESE PRESENTS REMISE, RELEASE AND QUIT CLAIM UNTO SAID PARTY OF THE SECOND PART HIS HEIRS AND ASSIGNS, ALL INTEREST OF THE SAID PARTY OF THE FIRST PART IN AND TO THE FOLLOWING DESCRIBED PROPERTY, SITUATED IN SKAMANIA COUNTY, STATE OF WASHINGTON, TO-WIT:

A ONE-FOURTH ($\frac{1}{4}$) INTEREST IN THE LA RICA QUARTZ CLAIM AS DISCOVERED AND RELOCATED ON DECEMBER, 15TH 1923 IN THE NIGGERHEAD MINING DISTRICT IN SAID COUNTY AND STATE BEING MORE PARTICULARLY DESCRIBED AS; ON THAT CERTAIN VEIN OR LODGE RUNNING IN A SOUTHEASTERLY BY NORTHWESTERLY (NORTH ' SOUTH 45 DEGREES VARIATION TO EAST) EXTENDING ALONG THE LEADS LODGE OR VEIN 1500 FEET SOUTHEASTERLY BY 300 FEET ON EACH SIDE OF CENTER OF LEAD.
