That Frank M. Seeley died at Medical Lake, in Spokane County, State of Washington, on or about the 22nd day of July, 1922, being at the time of his death a legal resident of Benton County, State of Washington.

GOSE, AGED ABOUT 50 YEARS, RESIDING AT OLYMPIA, WASHINGTON, A NEICE, AND KATIE ALLEN, AGED ABOUT 46 YEARS, RESIDING AT POMEROY, WASHINGTON, A NEICE; THE LAST TWO NAMED HEIRS BEING DAUGHTERS AND HEIRS AT LAW OF CHARLES H. SEELEY, DECEASED, A BROTHER OF FRANK M. SEELEY, DECEASED.

THAT SAID DECEASED, AT THE TIME OF HIS DEATH, DIED SEIZED OF THE REAL AND PERSONAL PROPERTY SET FORTH AND DESCRIBED IN THE PETITION ON FILE HEREIN.

That the annual rental value of the real property in Benton County, Washington, is approximately \$150.00, and in Skamania County, Washington, is approximately \$50.00; that the approximate value of the real property in Benton County, Washington, is the sum of \$3000.00, and in Skamania County, Washington, the value of the real property is approximately \$3000.00.

THAT THE TOTAL ESTIMATE VALUE OF THE PERSONAL PROPERTY OF WHICH THE DE-CEASED DIED SEIZED IS THE SUM OF \$6500.00.

THAT SAID DECEASED LEFT NO WIFE, CHILDREN, FATHER OR MOTHER SURVIVING HIM, AND THE SAID ELLA B. SEELEY, A SURVIVING SISTER, HAS PETITIONED THAT ONE HENRY OLDENSTADT BE APPOINTED ADMINISTRATOR OF SAID ESTATE, THE SAID HENRY OLDENSTADT BEING A FIT, SUITABLE AND COMPETENT PERSON TO BE APPOINTED ADMINISTRATOR OF THE ESTATE OF SAID DECEASED.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED THAT HENRY OLDENSTADT BE.

AND HE IS HEREBY APPOINTED ADMINISTRATOR OF THE ESTATE OF FRANK M. SEELEY, DECEASED,

WITHIN AND FOR THE STATE OF WASHINGTON, AND THE CLERK OF THIS COURT IS HEREBY

ORDERED AND DIRECTED TO ISSUE TO THE SAID HENRY OLDENSTADT LETTERS OF ADMINISTRATION

UPON HIS TAKING THE OATH OF OFFICE REQUIRED BY STATUTE AND GIVING A GOOD AND SUFFICIENT BOND TO THE STATE OF WASHINGTON IN THE SUM OF \$10,000. CONDITIONED FOR THE

FAITHFUL PERFORMANCE OF HIS DUTIES OF ADMINISTRATOR OF THE ESTATE OF SAID DECEASED.
