- (1) That certain canal situate, lying and being in Yakima County, State of Washington now commonly known as the Naches Power Canal of the Company, as now located, operated and maintained, which said canal has its point of beginning on the northerly side of the Naches River in section thirty-six (36), township fifteen (15) north, range sixteen (16) east of Willamette Meridian, and continues thence in a general easterly and southeasterly direction through said section thirty-six (36) and Sections thirty-one (31), thirty-two (32) and thirty-three (33) in township fifteen (15) north, range seventeen (17) east of Willamette Meridian, and sections four (4), three (3), two (2), eleven (11), twelve (12), thirteen (13) and twenty-four (24) in township fourteen (14) north, range seventeen east of Willamette Meridian; together with the pieces or parcels of land owned by the Company upon which said canal is now located or through which the same extends, including a strip of land extending the entire length of said canal and not less than seventy-five (75) feet in width at the narrowest point; also all lands, spillways, easements, right of way and privileges of the Company appurtenant to said canal or used in connection therewith, including certain wasteways or waste ditches used jointly with the owners of the Selah irrigation canal or ditch; subject, however, to certain covenants to furnish water therefrom to various corporations and individuals along said canal and/or at the lower end thereof, and to certain other covenants relating to the maintenance thereof, all as set forth in the recorded deeds and agreements relating to said canal or to the lands through which the same extends.
