KNOW ALL MEN BY THESE PRESENTS, THAT THE FIRST NATIONAL BANK A CORPORATION OF THE COUNTY OF HOOD RIVER, IN THE STATE OF OREGON, IN CONSIDERATION OF THE BENEFITS AND OTHER VALUABLE CONSIDERATIONS, AND THE SUM OF ONE DOLLAR, PAID, THE RECEIPT WHEREOF IS HEREBY ACKNOWLEDGED, HAVE GRANTED, BARGAINED, SOLD AND CONVEYED, AND BY THESE PRESENTS DO GRANT, BARGAIN, SELL AND CONVEY UNTO THE STATE OF WASHINGTON THE FOLLOWING DESCRIBED PARCEL OF LAND SITUATED IN SKAMANIA COUNTY, IN THE STATE OF WASHINGTON, TO-WIT:

A STRIP OF LAND 60 FEET WIDE, BEING 30 FEET ON EACH SIDE OF THE CENTER LINE OF SAID ROAD AS SURVEYED OVER AND ACROSS

THE NE $\frac{1}{4}$ OF SW $\frac{1}{4}$, SECTION 29, TWP. 3 NORTH, RANGE 8 E. W.M., WITH THE FOLLOWING EXCEPTION:

FROM STATION 22+50 TO STATION 24+25 SAID STRIP OF LAND IS TO BE 40 FEET ON THE NORTH SIDE AND 50 FEET ON THE SOUTH SIDE OF SAID CENTERLINE.

TO HAVE AND TO HOLD THE SAME, UNTO THE STATE OF WASHINGTON FOR THE PURPOSE OF A PUBLIC ROAD FOREVER.
