Lot Eight (8) opposite and adjoining Lot (1) of Section Twenty-four (24), beginning at the meander post between Sections Twenty-Three (23) and Twenty-Four (24) Township Eight (8) North, Range Five (5) West, Willamette Meridian; thence South 1.80 chains to a point; thence North 47 deg. East 6.00 chains to a point; thence South 62 deg. 30 min. West 5.00 chains to the point of beginning, the tidelands described in the four last above descriptions having a total frontage of 45.80 lineal chains, measured along the meander line, according to a certified copy of the Government field notes of the survey thereof on file in the office of the Commissioner of Public Lands at Olympia, Washington.

Tract No. W.W. 4: also all tide land of the third class formerly owned by the State of Washington, situate in front of, abutting upon and adjacent to Lot One (1), of Section 28, and Lot Two (2) of Section 27, Township 9 North, Range 6 West, Willamette Meridian; the meander line of said Lots bordering on said tide land being described according to the U. S. Government field notes as follows: Lot 2, Section 27, Township 9 North, Range 6 West; Beginning at a point on the U. S. Government meander line where the line between Lots 1 and 2 of said Section 27 would intersect the same; thence along the meander line in front of Lot 2 as follows: North 85 deg. West 16.71 chains; North 36 deg. West 5.20 chains to the meander corner to fractional sections 27 and 28 aforesaid; thence in front of Lot 1 aforesaid; North 35 deg. West 12.00 chains to the mouth of a slough 187 links wide, which comes from the North; thence West 2 chains; thence North 72 deg. 15 min. West 17.00 chains to the meander corner to fractional Sections 21 and 28, same township and range, which is 25.00 chains west (var. 22 deg. 30 min. East) of the corner to Sections 21, 22, 27 and 28, said Township and Range, having a total frontage measured on the meander line of said Lots 1 and 2, of 52.91 lineal chains.
