

of the ships documents attached thereto as to all of the above ships and boats that are either enrolled or registered and that as to all the aforementioned ships and boats which are neither registered nor enrolled, that the lien of said mortgage be released on the record thereof by the Collector at said Port by the filing in his office of a certified copy of this decree and any other paper or document required in connection therewith under the rules and regulations appertaining thereto; and that certified copies of this decree should also be filed and recorded in the several public records in the states of Oregon, Washington and the Territory of Alaska herein above specifically mentioned, and in the public records at any other place where said mortgage may have been recorded.

IT IS THEREFORE HEREBY CONSIDERED ORDERED AND DECREED BY THE COURT:

FIRST: That said mortgage executed by the above named debtor to Lumbermens Trust Company as Trustee under date of October 1, 1924 together with the debt thereby secured, and the bonds, coupons and certificates of indebtedness secured thereby, be and the same are in all respects hereby released, satisfied and discharged, save and except only that the holders of such of said bonds, coupons and certificates of indebtedness which have not heretofore been deposited with Title and Trust Company may be deposited with said Title and Trust Company for the purpose of enabling the owner thereof to acquire his proportionate part of the cash and debenture bonds on deposit, as aforesaid, with said Title and Trust Company.

SECOND: That certified copies of this decree be filed and recorded in the public records in the following places, to-wit: Clatsop County, Oregon, Columbia County, Oregon, Clarke County, Washington, Pacific County, Washington, Skamania County, Washington and Wahkiakum County, Washington; in the office of United States Commissioner and Recorder, Bristol Bay Precinct, Third Division, Dillingham, Alaska, and in the office of the United States Commissioner, Unga Peninsula Precinct, Unga, Alaska.

THIRD: That certified copies of this decree be filed at the United States Custom House at Astoria, Oregon, together with certified copies of ships documents for the ships and boats covered by said mortgage and un-released therefrom which are either enrolled or registered, and that the Collector of Customs at said port, upon receipt of the required certified copies of this decree with certified copies of said ships documents attached thereto, shall thereupon release, satisfy and discharge the lien of said mortgage against said ships and boats as the same appears on the records in his office; and as to any of the boats or ships covered by the lien of said mortgage which are neither enrolled nor registered, the lien of said mortgage shall be satisfied by the Collector of said port by filing with him of a certified copy of this decree and the compliance with any regulation or practice in his office required in connection therewith.

FOURTH: That the Title and Trust Company shall pay to the holders of the outstanding bonds of the debtor from said funds deposited with it in accordance with the terms of said refinancing plan and shall deliver the new debenture bonds to the holders of the bonds issued under date of October 1, 1924 and the coupons appurtenant thereto, and to the holders of the certificates of indebtedness issued on account of the non-payment in full of coupons or interest upon matured bonds, in the proportions provided in said plan, upon surrender of said bonds, certificates and coupons, and that said Title and Trust Company generally shall carry said plan into effect in the distribution and payment of said debentures and money.

FIFTH: That Title and Trust Company shall not record the trust deed securing said debentures and now deposited with said Title and Trust Company in escrow, in the custom house at Astoria, Oregon or any other public record until after the loan from the Recon-
