Michael Montchalin to Marie Montchalin

KNOW ALL MEN BY THESE PRESENTS, That Michael Montchalin, party of the first part, for and in consideration of the sum of One Dollar to him in hand paid by Marie Montchalin, his wife, party of the second part, does hereby Transfer, Assign and Set-over unto the said party of the second part all his right, title and interest in and to that certain indenture of mortgage bearing date the 18th day of August, 1932, made and executed by Emma Hill Yoe and Warren W.
