The East half of the Northeast Quarter of the Northeast Quarter and the Northwest Quarter of the Northeast Quarter of the Northeast Quarter of Section 22, and the West half of the Northwest Quarter and the Northwest Quarter of the Southwest Quarter of Section 23 in Township 4 North of Range 7 East of the Willamette Meridian, in said county, State of Washington, containing One Hundred Fifty acres:
