THE EAST HALF ( $E\frac{1}{2}$ ) OF THE NORTHEAST QUARTER ( $NE\frac{1}{4}$ ) OF THE SOUTHEAST QUARTER ( $SE\frac{1}{4}$ ) OF SECTION NINE IN TOWNSHIP THREE NORTH OF RANGE TEN EAST OF W.M., CONTAINING TWENTY (20) ACRES, MORE OR LESS.
