Monsuetti Tavelli to Julia Di Angelo

THIS INDENTURE, Made this 4th day of November, in the year of our Lord one thousand nine hundred and thirty-five, Between Monsuetti Tavelli, a widower, party of the first part, and Julia Di Angelo, party of the second part;

WITNESSETH, That the said party of the first part, for and in consideration of the sum of Six Hundred and no/100 Dollars, lawful money of the United States, to him in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, does by these presents, Grant, Bargain, Sell, Convey and Warrant unto the said party of the second part, and to her heirs and assigns, the following described tract or parcel of land, lying and being in the County of Skamania and State of Washington, and particularly bounded and described as follows, to-wit:

The northwest quarter of the northwest quarter of section two (2), township one (1) north of range five (5) East of the Willamette Meridian, in Skamania County, State of Washington, except an undivided one half interest of all the water that flows from a spring located upon said tract of land as reserved by James H. Miller et ux, said spring being located on E.M.H. the southeast part of said tract of land and the water crossing the south boundary of said tract eight (8) chains west from the southeast corner of said forty (40) acres of land, it being understood that James H. Miller et ux E.M.H. have and own an undivided one half interest in and to said spring and all water flowing therefrom, and shall have the right to lay water pipes from said spring and keep the same in repair, in order to carry one half of the water from said spring to any place that they may desire. Also the following tract of land, to-wit: There being seven and one fourth (7¼) acres, more or less, in the northern part of the SW¼ of NW¼ of section two (2), township one (1) north range five (5) east W.M. in Skamania County, Washington, commencing at a point in the center of County Road (7.56) chains north of quarter section corner on line between sections two (2) and three (3) town one (1) north of range five (5) E.W.M.; running thence north eighteen (18) degrees and 25 minutes east 6 chains from which brs. a fir 36" S. 64° 36' E Mk. R. 19 dist.
