Sam Angelo et ux to Dora Persichell

KNOW ALL MEN BY THESE PRESENTS, That Sam Angelo and Julia Angelo, husband and wife, the parties of the first part, for and in consideration of the sum of One Dollar and other valuable consideration of the United States of America, to them in hand paid by Dora Persichell the party of the second part, the receipt whereof is hereby acknowledged, have granted, bargained, sold, assigned, transferred and set over, and by these presents do grant, bargain, sell, assign, transfer and set over unto the said party of the second part, a certain Indenture of Mortgage, bearing date the third day of March, 1931, made and executed by Pietro Giotti, a single man, to Sam Angelo and Julia Angelo to secure the payment of the sum of One Thousand (\$1000.00) Dollars, together with the \_\_\_\_\_ or obligation therein described, and the money due, or to grow due thereon, with the interest; which said Indenture of Mortgage was recorded in the office of the County Auditor of Skamania County, State
