KNOW ALL MEN BY THESE PRESENTS THAT FRED WISE IN THE COUNTY OF MARION AND STATE OF OREGON HAS MADE, CONSTITUTED AND APPOINTED, AND BY THESE PRESENTS DO MAKE, CONSTITUTE AND APPOINT RAYMOND MEIGGS OF UNDERWOOD IN THE COUNTY OF SKAMANIA, STATE OF WASHINGTON MY TRUE AND LAWFUL ATTORNEY, FOR HIM AND IN HIS NAME PLACE AND STEAD, TO

IT IS THE INTENT AND PURPOSE OF THIS POWER OF ATTORNEY TO BE GENERAL IN ITS BROADEST TERMS, TO AUTHORIZE MY ATTORNEY-IN-FACT TO SELL ANY AND ALL PERSONAL OR REAL PROPERTY AND GIVE THE NECESSARY CONVEYANCES THEREFOR TO TRANSFER TITLE; TO PAY ALL DEBTS THAT I OWE AND TO COLLECT ALL MONEY'S DUE ME OF EVERY NATURE OR KIND; TO ISSUE RECEIPTS THEREFOR, AND TO COMMENCE ACTIONS IN COURT, IF NECESSARY, TO COLLECT THE SAME, AND TO TRANSFER FOR ME AND IN MY BEHALF ANY OR ALL BUSINESS THAT I HAVE AN INTEREST IN OR THAT IS TO MY BEST INTEREST, AND TO PROTECT MY PROPERTY RIGHTS, GIVING AND GRANTING UNTO MY SAID ATTORNEY FULL POWER AND AUTHORITY TO DO AND PERFORM ALL AND EVERY ACT AND THING WHATSOEVER REQUISITE AND NECESSARY TO BE DONE IN AND ABOUT THE PREMISES, AS FULLY TO ALL INTENTS AND PURPOSES AS I MIGHT OR COULD DO IF PERSONALLY PRESENT, WITH FULL POWER OF SUBSTITUTION AND REVOCATION, HEREBY RATIFYING AND CONFIRMING ALL THAT MY SAID ATTORNEY OR HIS SUBSTITUTE SHALL LAWFULLY DO OR CAUSE TO BE DONE BY VIRTUE THEREOF.
