That, whereas, said John T. Haffey and Lulu Haffey are the owners of certain real estate described as follows, to-wit:

NOW, THEREFORE, in consideration of the love and affection that each of said parties has for the other, it is hereby agreed that in case of the death of the said John T. Haffey while the said Lulu Haffey survives, the whole of said property hereinbefore described, together with any other property by them hereafter acquired, shall at once vest in said Lulu Haffey in fee simple, and in the event of the death of said Lulu Haffey while the said John T. Haffey survives, the whole of said property hereinbefore described, together with any other property by them hereafter acquired, shall at once vest in the said John T. Haffey in fee simple.
