

FRANK A. KANE TO LOUIS S. WILSON ET AL

THIS INDENTURE, MADE THE 18TH DAY OF JUNE IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-FOUR BETWEEN FRANK A. KANE, AN UNMARRIED MAN, THE PARTY OF THE FIRST PART, AND LOUIS S. WILSON AND L. A. MICHELSON, BOTH OF SEATTLE, WASHINGTON, THE PARTIES OF THE SECOND PART, WITNESSETH: THAT THE SAID PARTY OF THE FIRST PART, FOR AND IN CONSIDERATION OF THE SUM OF ONE DOLLAR AND OTHER CONSIDERATIONS LAWFUL MONEY OF THE UNITED STATES OF AMERICA, TO HIM IN HAND PAID BY THE SAID PARTIES OF THE SECOND PART, THE RECEIPT WHEREOF IS HEREBY ACKNOWLEDGED, HAS GRANTED, BARGAINED, SOLD, REMISED, RELEASED AND FOREVER QUIT-CLAIMED, AND BY THESE PRESENTS DOES GRANT, BARGAIN, SELL, REMISE, RELEASE AND FOREVER QUIT-CLAIM UNTO THE SAID PARTIES OF THE SECOND PART, AND TO THEIR HEIRS AND ASSIGNS, TO EACH OF SAID GRANTEES, AN UNDIVIDED $1/3$ INTEREST IN ALL MY RIGHT, TITLE AND INTEREST IN AND TO THAT CERTAIN QUARTZ MINING CLAIM, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

1500 LINEAL FEET AND HORIZONTAL MEASURE ALONG THE ACME QUARTZ CLAIM INCLUDING ALL DIPS, SPURS AND ANGLES AND VARIATIONS IN AN SOUTHEASTERLY DIRECTION (NORTH AND SOUTH 60° VARIATION TO THE EAST) AND MORE PARTICULARLY DESCRIBED AS FOLLOWS;"BEGINNING AT THIS NOTICE WHICH IS DISCOVERY AND RUNNING NORTHERLY 600 FEET TO SOUTH CENTER END OF LARICA EXTENSION NO. 5 AND SOUTHEASTERLY 900 FEET TO SOUTHEASTERLY END CENTER TOGETHER WITH 300 FEET ON EACH SIDE OF CENTER OF LEAD LODE OR VEIN. ALL CORNERS MARKED AND CENTER LINE BLAZED, IN NIGGERHEAD MINING DISTRICT, SKAMANIA COUNTY, WASHINGTON.

DISCOVERY AT TOP OF DIVIDE EAST OF RED BUTTE ABOUT 400 FEET FROM TOP OF BUTTE ON EAST CANYON CREEK AND IS AN EXTENSION OF THE LARICA GROUP OF CLAIMS, LOCATED THIS 9TH DAY OF JUNE, 1924," BY FRANK A. KANE, THE ABOVE NAMED GRANTOR.

TOGETHER WITH ALL THE DIPS, SPURS AND ANGLES, AND ALSO ALL THE METALS, ORES, GOLD AND SILVER BEARING QUARTZ, ROCK AND EARTH THEREIN; AND ALL THE RIGHTS, PRIVILEGES AND FRANCHISES THERETO INCIDENT, APPENDANT AND APPURTENANT OR THEREWITH USUALLY HAD AND ENJOYED; AND, ALSO, ALL AND SINGULAR THE TENEMENTS, HEREDITAMENTS AND APPURTENANCES THEREUNTO BELONGING OR IN ANYWISE APPERTAINING, AND THE RENTS, ISSUES AND PROFITS THEREOF; AND, ALSO, ALL THE ESTATE, RIGHT, TITLE, INTEREST, PROPERTY, POSSESSION, CLAIM AND DEMAND WHATSOEVER, AS WELL IN LAW AS IN EQUITY, OF THE SAID PARTIES OF THE FIRST PART, OF, IN OR TO THE SAID PREMISES, AND EVERY PART AND PARCEL THEREOF, WITH THE APPURTENANCES,

TO HAVE AND TO HOLD, ALL AND SINGULAR, THE SAID PREMISES, TOGETHER WITH THE APPURTENANCES AND PRIVILEGES THEREUNTO INCIDENT, UNTO THE SAID PARTIES OF THE SECOND PART, THEIR HEIRS AND ASSIGNS FOREVER.

BY THIS DEED, THE ABOVE DESCRIBED CLAIM IS OWNED BY FRANK A. KANE, GRANTOR LOUIS S. WILSON AND L. A. MICHELSON, EACH OWNING $1/3$ THEREOF.
