WITNESSETH, That the said parties of the first part, for and in consideration of the sum of Five Hundred and Seventy-five Dollars, lawful money of the United States, to them in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, do by these presents, Grant, Bargain, Sell, Convey and Warrant unto the said party of the second part, and to its successors, and assigns, the following described tract or parcel of land, lying and being in the County of Skamania, and State of Washington, and particularly bounded and described as follows, to-wit:

Lots Two (2) and Three (3), Block One (1), Cascades Addition to the Town of Stevenson, according to the official plat thereof on file and of record in the office of the Auditor of Skamania County, Washington.

together with all and singular the tenements, hereditaments and appurtenances thereunto belonging.

THIS CONVEYANCE is intended as a Mortgage to secure the payment of Five Hundred and Seventy-five Dollars, lawful money of the United States, together with interest thereon at the rate of \_\_\_per cent per annum from date until paid, according to the terms and conditions of one certain promissory note, bearing date October 3, 1936, made by parties of the first part payable in monthly installments of not less than \$15.00 per month, commencing October 15, 1936, and a like payment on the 15th of each month thereafter to the order of Bank of Stevenson, a corporation, until whole sum has been paid and these presents shall be void if such payment be made according to the terms and conditions thereof.
