THIS INDENTURE, MADE THIS TWENTY-FIRST (21ST) DAY OF APRIL IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-TWO (1922) BETWEEN JOHN MEAD AND ELSIE MEAD HIS WIFE AND ALEXANDER ROBERTSON AND E MAUDE ROBERTSON HIS WIFE ALL OF IONIA COUNTY, MICHIGAN. OF THE FIRST PART, AND FLOYD BEACH OF THE SECOND PART,

WITNESSETH, THAT THE SAID PARTIES OF THE FIRST PART, FOR AND IN CONSIDERATION OF THE SUM OF ONE DOLLAR TO THEM IN HAND PAID BY THE SAID PARTY OF THE SECOND PART, THE RECEIPT WHEREOF IS HEREBY CONFESSED AND ACKNOWLEDGED, DO BY THESE PRESENTS GRANT, BARGAIN, SELL, REMISE, RELEASE, AND FOREVER QUIT-CLAIM UNTO THE SAID PARTY OF THE SECOND PART, AND TO HIS HEIRS AND ASSIGNS, FOREVER, ALL THAT CERTAIN PIECE OR PARCEL OF LAND SITUATE IN THE COUNTY OF SKAMANIA IN AND STATE OF WASHINGTON, KNOWN AND DESCRIBED AS FOLLOWS:

THE SOUTHEAST QUARTER ($\frac{1}{4}$) OF SECTION NUMBER FIVE (5), TOWNSHIP NUMBER TWO (2) NORTH OF RANGE SIX (6) EAST OF THE WILLAMETTE MERIDIAN, CONTAINING ONE HUNDRED SIXTY (160) ACRES OF LAND MORE OR LESS ACCORDING TO THE GOVERNMENT SURVEY THEREOF.

TOGETHER WITH ALL AND SINGULAR THE HEREDITAMENTS AND APPURTENANCES THEREUNTO BELONGING OR IN ANYWISE APPERTAINING:

TO HAVE AND TO HOLD THE SAID FIRST PARTIES TO THE SAID PARTY OF THE SECOND PART, AND TO HIS HEIRS AND ASSIGNS, TO THE SOLE AND ONLY PROPER USE, BENEFIT AND BEHOOF, OF THE SAID PARTY OF THE SECOND PART, HIS HEIRS AND ASSIGNS, FOREVER.
