KNOW ALL MEN BY THESE PRESENTS THAT JAMES ROSSI CITIZEN OF THE UNITED STATES OVER THE AGE OF TWENTY-ONE YEARS, HAVE MADE, CONSTITUTED AND APPOINTED, AND BY THESE PRESENTS DOES MAKE, CONSTITUTE AND APPOINT ROMEO TRONCA MY TRUE AND LAWFUL ATTORNEY FOR ME AND IN MY NAME AND PLACE AND STEAD TO LOCATE, STAKE AND RECORD FOR ME AND IN MY NAME LODE CLAIMS AND PLACER MINING GROUND IN MT. ST.
