KNOW ALL MEN BY THESE PRESENTS THAT JOHN GATT CITIZEN OF THE UNITED STATES OVER THE AGE OF TWENTY-ONE YEARS, HAS MADE, CONSTITUTED AND APPOINTED, AND BY THESE PRESENTS DOES MAKE, CONSTITUTE AND APPOINT ROMEO TRONCA HIS TRUE AND LAWFUL ATTORNEY FOR HIM AND IN HIS NAME AND PLACE AND STEAD TO LOCATE, STAKE AND RECORD FOR HIM AND IN HIS NAME LODE CLAIMS AND PLACER MINING GROUND IN MT. ST. HELENS MINING DISTRICT, SKAMANIA COUNTY, WASHINGTON, OR IN ANY OTHER PLACE WITHIN THE STATE OF WASHINGTON OR AT SUCH OTHER PLACES AS HE MAY DEEM ADVISABLE, AND HAVING LOCATED THE SAME, TO BARGAIN, SELL, GRANT, RELEASE AND CONVEY THE SAME, ENTIRE OR IN SEPARATE PARCELS, UPON SUCH TERMS AS HE MAY DEEM EXPEDIENT, TO MAKE PROPER DEEDS, CONTRACTS OF SALE, BONDS, LEASES OR OTHER DOCUMENTS RELATING THERETO, TO EXECUTE, ACKNOWLEDGE AND DELIVER THE SAME TO SUCH PERSONS AS MY ATTORNEY MAY DESIRE; HEREBY GIVING AND GRANTING UNTO MY SAID ATTORNEY FULL POWER AND AUTHORITY TO DO AND PERFORM ALL AND EVERY ACT AND THING WHATSOEVER REQUISITE AND NECESSARY TO BE DONE IN AND ABOUT THE PREMISES, AS FULLY TO ALL INTENTS AND PURPOSES, AS I MIGHT OR COULD DO IF PERSONALLY PRESENT HEREBY RATIFYING AND CONFIRMING ALL THAT MY SAID ATTORNEY SHALL LAWFULLY DO OR CAUSE TO BE DONE BY VIRTUE OF THESE PRESENTS.
