THIRD. I HEREBY GIVE DEVISE AND BEQUEATH UNTO MY SISTER SOPHIA FOGLEBOUGH OF ERIE COUNTY, PENNSYLVANIA, THE SUM OF ONE DOLLAR.

FOURTH. I GIVE DEVISE AND BEQUEATH UNTO MY FRIEND AGNES M. WEBSTER, WHO IS THE DAUGHTER OF MY FIRST HUSBAND, JOSEPH FLETCHER, THE SAID AGNES M. WEBSTER, NOW BEING AN INHABITANT OF THE TOWN OF EUREKA, STATE OF CALIFORNIA, THE SUM OF FIVE (\$500.00) HUNDRED DOLLARS.

FIFTH. I GIVE DEVISE AND BEQUEATH UNTO VIVIAN SHELLEY, WHO IS A DAUGHTER OF MY STEP-SON, RALPH SHELLEY, THE SUM OF FIVE (\$500.00) HUNDRED DOLLARS, THE SAID VIVIAN SHELLEY NOW BEING AN INHABITANT OF THE CITY OF PORTLAND, OREGON.

IN THE EVENT THAT I SHOULD DIE BEFORE THE SAID VIVIAN SHELLEY SHALL REACH HER MAJORITY, I REQUEST THAT H. T. SHELLEY, BE APPOINTED AS THE GUARDIAN OF THE ESTATE OF THE SAID VIVIAN SHELLEY.

SIXTH. ALL THE REST AND RESIDUE OF MY ESTATE BOTH PERSONAL REAL AND MIXED, I GIVE, DEVISE AND BEQUEATH UNTO MY STEP-SON, HUGH T. SHELLEY WHOSE RESIDENCE IS THE CITY OF PORTLAND, MULTNOMAH COUNTY, OREGON.

SEVENTH. IN THE EVENT THAT THE BEQUESTS AND GIFTS WHICH I HAVE MADE UNTO AGNES M. WEBSTER AND VIVIAN SHELLEY, WHICH TOTAL THE SUM OF ONE THOUSAND DOLLARS SHOULD BE EQUAL TO MORE THAN ONE-HALF OF THE RESIDUE OF MY ESTATE, AFTER THE PAYMENT OF ALL JUST CLAIMS AGAINST MY ESTATE AND MY FUNERAL EXPENSES, I HEREBY EXPRESSLY ORDER AND DIRECT THAT THE SAID BEQUESTS AND GIFTS SO MADE TO THE PERSONS HEREIN NAMED BE PROPORTIONATELY REDUCED IN AMOUNT, UNTIL SAID GIFTS AND BEQUESTS SHALL NOT EXCEED ONE-HALF OF THE RESIDUE OF MY SAID ESTATE. IT IS MY EXPRESS ORDER AND DESIRE THAT THE GIFT AND DEVISE MADE UNTO HUGH T. SHELLEY SHALL BE EQUAL TO AT LEAST ONE-HALF OF THE RESIDUE OF MY ESTATE.

EIGHTH. I NOMINATE, CONSTITUTE AND APPOINT HUGH T. SHELLEY TO BE THE EXECUTOR OF THIS MY LAST WILL AND TESTAMENT, AND I DIRECT THAT HE SHALL SERVE IN SAID CAPACITY WITHOUT BOND OR UNDERTAKING OF ANY NATURE.

LASTLY. I HEREBY REVOKE ALL OTHER WILLS, LEGACIES AND DEVICES BY ME HERETOFORE MADE AND DECLARE THIS AND NONE OTHER TO BE MY LAST WILL AND TESTAMENT.
