KNOW ALL MEN BY THESE PRESENTS, That Bank of Stevenson, a corporation, mortgagee in that certain mortgage dated June 15, 1936, recorded June 17, 1936 at page 603 Book "T" of Mtgs., records of Skamania County, Washington, made and executed by H. E. Rogers and Aletta R. Rogers, husband and wife, in consideration of the sum of One Dollar and other consideration, does hereby Release and Discharge from the terms of the aforesaid mortgage and from the lien thereof the following described real property, to-wit:

Commencing at a point 30 feet South and 360 feet West of the North east corner of Lot 9 Section 1 Township 2 North of Range 7 E. W.M., thence South 236 feet; thence West 100 feet; thence North 236 feet; thence East 100 feet to the point of beginning. Together with the right to the use of that certain well situate on the East line of the above described tract and the land surrounding the same within a radius of 10 feet and the rights privileges and easements granted unto M. W. Beck and Charlotte Ann Beck, husband and wife, by deed from H. E. Rogers and Aletta R. Rogers, husband and wife, of even date herewith.

To the intent and purpose that the above described premises shall be discharged from the lien thereof but that the balance of the real property described in said mortgage shall remain subject to the lien and therem thereof as aforesaid.
