THIS INDENTURE, MADE THIS 29TH DAY OF NOVEMBER 1924 BETWEEN SKAMANIA COUNTY, A MUNICIPAL CORPORATION OF THE STATE OF WASHINGTON, PARTY OF THE FIRST PART, AND E. C. HAMILTON, PARTY OF THE SECOND PART, WITNESSETH: THAT, WHEREAS, BY RESOLUTION DULY PASSED ON THE SECOND DAY OF JULY 1923, BY THE BOARD OF COUNTY COMMISSIONERS OF SKAMANIA ... WASHINGTON, IT WAS DETERMINED TO BE FOR THE BEST INTEREST OF SAID COUNTY AND THE PEOPLE THEREOF, THAT THE FOLLOWING DESCRIBED PROPERTY BE SOLD ACCORDING TO LAW, TO-WIT:

LOTS THIRTEEN AND FOURTEEN IN BLOCK FOUR OF THE UPPER CASCADES ADDITION TO THE TOWN OF STEVENSON, WASHINGTON ACCORDING TO THE OFFICIAL PLAT THEREOF ON FILE IN THE OFFICE OF THE COUNTY AUDITOR, OF SAID COUNTY.

AND THAT A HEARING BE HAD BY THE BOARD OF COMMISSIONERS AT THEIR USUAL PLACE OF MEETING IN THE COURT HOUSE AT STEVENSON, WASHINGTON, AT THE HOUR OF 1-30 O'CLOCK P.M. ON THE 2ND DAY OF JULY 1923, UPON THE ADVISABILITY OF SELLING THE ABOVE DESCRIBED PROPERTY, AND DIRECTING THE AUDITOR TO GIVE NOTICE THEREOF AS DESCRIBED BY LAW;
