ONE DOLLAR TO THEM IN HAND PAID BY W. A. ARNOLD AND FANNIE A. ARNOLD, HUSBAND AND
WIFE, PARTIES OF THE SECOND PART, DO HEREBY REMISE, RELEASE AND FOREVER QUITCLAIM
UNTO THE SAID PARTIES OF THE SECOND PART, ALL RIGHT, TITLE AND INTEREST IN AND TO
THE FOLLOWING DESCRIBED REAL PROPERTY IN SKAMANIA COUNTY, WASHINGTON, TO-WIT:
