SUSIE HAMMOND, A DAUGHTER, NOW ABOUT 50 YEARS OF AGE WHO RESIDES IN SAID CITY OF PORTLAND.

JANE SMITH, A DAUGHTER, NOW ABOUT 38 YEARS OF AGE WHO RESIDES IN SAID CITY OF PORTLAND. OREGON.

JAMES VINCENT, A SON, NOW ABOUT 59 YEARS OF AGE WHO RESIDES IN SAID CITY OF PORTLAND, OREGON.
