WHEREAS, on or about June 17, 1927, a Third Supplemental Indenture dated June 17, 1927, was duly executed and delivered by and between Peoples West Coast Hydro-Electric Corporation, and The Equitable Trust Company of New York and Samuel Armstrong, as Trustees, and Security Savings and Trust Company, substitute Trustee, whereby certain additional property acquired by Peoples West Coast Hydro-Electric Corporation located in the State of Oregon was conveyed to said Substitute Trustee upon the trusts and conditions set forth and declared in said Third Supplemental Indenture, and whereby Peoples West Coast Hydro-Electric Corporation, and The Equitable Trust Company of New York and Samuel Armstrong, Trustees, confirmed the appointment of Security Savings and Trust Company as substitute Trustee of that part of the trust estate located in the State of Oregon, which Third Supplemental Indenture was thereafter duly recorded and filed as follows;
