NOW, THEREFORE, THIS INDENTURE WITNESSETH:

That The Chase National Bank of the City of New York and Samuel Armstrong, as Trustees as aforesaid and Boise Trust Company and The First National Bank of Portland, as separate Trustee and substitute Trustee, respectively, as aforesaid, hereby certify and acknowledge that the Mortgage and the above-mentioned Indentures and Supplemental Indentures supplemental to the Mortgage have been paid, satisfied and discharged in full, and do hereby remise, release and quitclaim unto the person or persons legally entitled thereto all their right, title and interest, as Trustees and as separate Trustee and as substitute Trustee, respectively, as aforesaid, under the Mortgage and the above mentioned Indentures and Supplemental Indentures supplemental to the Mortgage, in and to all of the property subject to the lien thereof.

TO HAVE AND TO HOLD THE SAME with all appurtenances thereto belonging to, free, clear and discharged from the lien of the Mortgage and the above-mentioned Indentures and supplemental Indentures supplemental to the Mortgage.

IN WITNESS WHEREOF, The Chase National Bank of the City of New York has caused these presents to be signed by one of its vice presidents and its corporate seal to be hereunto affixed and attested by one of its assistant cashiers, and Boise Trust Company has caused these presents to be signed by its president and its corporate seal to be hereunto affixed and attested by one of its assistant secretaries, and The First National Bank of Portland has caused these presents to be signed by one of its vice presidents and its corporate seal to be hereunto affixed and attested by one of its assistant Trust officers, and Samuel Armstrong has hereunto set his hand and seal, all as of the 4th day of February, 1938.
