(b) Hydro-electric generating plants on Big Wood River at Hailey and Bellevue and Electric transmission and distribution systems.

3. (a) Easements at Indian Springs and for underground conduits therefrom to the City of Hailey.

(b) Easements described in deed dated November 6, 1926, to the Company from Wood River Power Company, recorded in Book 127 of Deeds at page 499 in the records of said Blaine County.

(c) Franchise granted by Ordinance No. 54, May 16, 1906, by the Village (now City) of Hailey, to the Company's predecessor, Leo Cramer.

(d) Franchise granted by Ordinance No. 40, December 12, 1904, by the Village (now City) of Hailey, to the Company's predecessor, Idaho Electric Supply Company.

(e) Franchise granted by Ordinance No. 59, October 2, 1912, by the City of Bellevue to the Company's predecessor, Rockwell-White Power Company.

(f) Franchise granted by Ordinance No. 11 October 23, 1919, by the Village (now dis-incorporated) of Carey, to the Company's predecessor, Wood River Power Company.

(g) Franchise granted January 19, 1916, by the Board of County Commissioners of Blaine County to the Company's predecessor, Rockwell-White Power Company, a corporation.

4. (a) The right to the use of the first 131 miner's inches flowing from the springs forming the sources of Indian Creek identified as a portion of the water of said creek decreed to the Company's predecessor, Hailey Water & Power Company, by judgment entered in the District Court of the Fourth Judicial District of the State of Idaho in and for Lincoln County, in a case entitled "S.C. Frost et al v. Alturas Water Company et al.", commonly known as the Big Wood River Water Suit, said decree being recorded in Book 1 of Civil Judgment Records at page 151 thereof among the records of Lincoln County, Idaho, and in Book 6 of Judgments at page 447 thereof among the records of Blaine County, Idaho.

(b) Water Right on Big Wood River evidenced by State of Idaho Water License No. 3295 dated August 7, 1917, issued to the Company's predecessor, Rockwell-White Power Company.

(c) Water Right on Big Wood River evidenced by State of Idaho Water License No. 1015, dated December 24, 1908, issued to the Company's predecessor, Cramer Electric Company.
