BEGINNING AT A POINT 1020 FEET NORTH OF THE SOUTHWEST CORNER OF THE NORTHWEST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 21 Tp. 3 N. R. 8 EAST OF W.M., THENCE EAST $657\frac{1}{2}$ FEET; THENCE NORTH 660 FEET; THENCE WEST $657\frac{1}{2}$ FEET; THENCE SOUTH 660 FEET TO THE PLACE OF BEGINNING.
