SUBJECT TO A MORTGAGE IN THE AMOUNT OF \$7500.00 WHICH IS A PART OF THE CONSIDERATION GRANTEE PROMISES AND AGREES TO PAY, AND RELIEVE GRANTOR FROM LIABILITY THEREON.
