JORDAN OF STEVENSON, WASH. PARTIES OF THE SECOND PART, HAVE GRANTED, BARGAINED AND SOLD, AND BY THESE PRESENTS DO GRANT, BARGAIN, SELL AND CONVEY UNTO THE SAID PARTY OF THE SECOND PART, AND TO HIS HEIRS AND ASSIGNS, THE FOLLOWING DESCRIBED REAL PROPERTY. SITUATE, LYING AND BEING IN THE COUNTY OF SKAMANIA STATE OF WASHINGTON, TO-WIT:

COMMENCING AT A POINT ON THE NORTH LINE OF LOT TWO STEVENSON PARK ADDITION ADDITION ACCORDING TO THE OFFICIAL PLAT THEREOF FILED IN PLAT BOOK A, RECORDS OF SKAMANIA CO.
