That the said parties of the first part, for and in consideration of the sum of One hundred forty and 84/100 Dollars, lawful money of the United States, to them in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, do by these presents, Grant, Bargain, Sell, Convey and Warrant unto the said party of the second part, and to its successors and assigns, the following described real property in Skamania County, Washington, To-wit:

Commencing at a point Ten chains East and 1320 feet North of the intersection of the West boundary of the Joseph Robbins Donation Land Claim with the South boundary of Section 27 in Twp 3 N. R. 8 E. W.
