KNOW ALL MEN BY THESE PRESENTS, THAT PEDER G. BIRKELAND AND FRIEDA BIRKELAND, HIS WIFE, OF THE COUNTY OF SKAMANIA, STATE OF WASHINGTON, FOR AND IN CONSIDERATION OF THE SUM OF THREE HUNDRED DOLLARS, IN HAND PAID, THE RECEIPT WHEREOF IS HEREBY ACKNOWLEDGED, DO HEREBY GRANT UNTO THE STATE OF WASHINGTON, THE RIGHT TO WASTE MATERIALS, CONSISTING OF ROCK, SAND AND EARTH FROM STATE ROAD No. 8 UPON ANY PORTION OF THE HERINAFTER DESCRIBED TRACT OF LAND, FOR THE PURPOSE OF MAINTAINING AND REPAIRING STATE ROAD No. 8 AT ANY AND ALL TIMES, FROM DATE HEREOF, FOR A PERIOD OF THREE (3) YEARS, TOGETHER WITH THE RIGHT TO OPERATE NECESSARY EQUIPMENT THEREON AND THE RIGHT OF INGRESS AND EGRESS FOR THE PURPOSE OF WASTING THEREON SAID MATERIALS FROM THE RIGHT OF WAY OF STATE ROAD No. 8, SAID TRACT OF LAND BEING SITUATED IN THE COUNTY OF SKAMANIA, STATE OF WASHINGTON AND DESCRIBED AS FOLLOWS, TO-WIT:

A TRACT OF LAND IN LOT 3, SECTION 22, TWP. 2 N. R. 7 E.
