#23719 Northwestern Electric Co. to Harris Trust & Savings Bank

THIS SUPPLEMENTAL INDENTURE, made and entered into as of the 1st day of December, 1936, by and between Northwestern Electric Company, a corporation organized under the laws of the State of Washington, and having its executive offices in the City of Portland, Oregon, (hereinafter referred to as "the Company"), and Harris Trust and Savings Bank, a corporation organized under the laws of the State of Illinois, and having its principal place of business in the City of Chicago, Illinois, (hereinafter referred to as "the Trustee") and Howard W. Fenton of said City (hereinafter referred to as "the Co-Trustee"), said Trustee and said Co-Trustee being hereinafter referred to as "the Trustees", WITNESSETH:

WHEREAS by a certain Trust Indenture, made and entered into by the Company and the Trustees under date of May 1, 1915, the Company conveyed to the Trustees all of its property, real and personal, including all property thereafter to be acquired, to secure an issue of \$10,000,000 in principal amount of First Mortgage Twenty Year Sinking Fund Gold Bonds, dated May 1, 1915, and due May 1, 1935, said Trust Indenture having been recorded as a mortgage of real and personal property as follows:

- Multnomah County, Oregon, on June 10th, 1915, Book 592 of Mortgages, at page 304;
- Clarke County, Washington, on June 12th, 1915, Book 114 of Mortgages, at page 1;
- Klickitat County, Washington, on June 11th, 1915, Book 38 of Mortgages, at page 14;
- Skamania County, Washington, on June 8th, 1915, Book "M" of Mortgages, at page 576;
- Cowlitz County, Washington, on June 11th, 1915, Book 67 of Mortgages, at page 285.

WHEREAS bonds were issued under and pursuant to said Trust Indenture in the aggregate principal amount of \$8,793,600, of which amount, on May 1, 1935, bonds in the principal amount of \$2,137,000 had been acquired for and were being held in the sinking fund for the purposes specified in Article IV of said Trust Indenture; and

WHEREAS the Company, being unable to pay the principal of said bonds on May 1, 1935, the date of maturity thereof, and desiring to secure an extension of time for such payment to May 1, 1945, submitted a proposal to that and addressed to the holders of the said bonds in the form of a certain proposed Extension Agreement, and on June 17, 1935, submitted said proposed Extension Agreement as a plan of reorganization to the District Court of the United States for the District of Oregon pursuant to the provisions of Section 77B of the Bankruptcy Act of the United States as amended; and

WHEREAS by an order entered on July 22, 1935, said Court confirmed said Extension
