A STRIP OF LAND 400 FEET WIDE, BEING 400 FEET ON THE NORTH SIDE OF THE CENTER LINE OF SAID ROAD AS SURVEYED OVER AND ACROSS LOTS 2 AND 3 (TAX LOT NO. 1), SECTION 22, TOWNSHIP TWO (2) NORTH, RANGE SEVEN (7) EAST OF THE WILLAMETTE MERIDIAN, EXCEPTING THEREFROM THE RIGHT OF WAY OF SAID ROAD NO. 8.
