PARTIAL RELEASE OF MORTGAGE

THIS CERTIFIES THAT THE FEDERAL LAND BANK OF SPOKANE, a corporation organized and existing under the Federal Farm Loan Act, approved July 17, 1916, for and in consideration of the sum of One Dollar and other good and valuable consideration, hereby releases from the lien of that certain mortgage, executed by Rose E. Breslin, a widow, to THE FEDERAL LAND BANK OF SPOKANE, dated October 9th, 1917, and recorded in Book Q of Mortgages on page 46, in the office of the County Auditor of Skamania County, State of Washington, that part of the property covered by said mortgage, described as follows:

Beginning at a point 1900 feet East of the Southwest corner of the Northwest Quarter of the Northwest Quarter of Section Thirty-three, Township Two North, Range Five East of the Willamette Meridian, thence East 740 feet to the Southeast corner of the Northeast Quarter of the Northwest Quarter of said Section Thirty-three, thence North 160 feet, thence West 740 feet, thence South 160 feet to the place of beginning.

It is expressly understood that this release shall not in any way affect or impair the right of The Federal Land Bank of Spokane to hold under the said mortgage and as security for the sum remaining due thereon the remainder of the premises therein conveyed and not hereby released.
