

SIX (6) TOWNSHIP ONE (1) NORTH OF RANGE FIVE (5) EAST OF THE W.M. RUNNING THENCE NORTH ALONG THE EAST LINE OF SAID SOUTHWEST QUARTER SIXTEEN (16) RODS AND TEN (10) FEET, BEING ALONG THE COUNTY ROAD; THENCE NORTHWESTERLY ALONG THE COUNTY ROAD EIGHTY-THREE (83) RODS TO A POINT AT WHICH THE FORMER PRIVATE ROAD KNOWN AS THE MARRIN & DIDIER ROAD NOW A COUNTY ROAD; INTERSECTS THE SAID COUNTY ROAD; THENCE SOUTHWETSERLY AND FOLLOWING THE SAID PRIVATE ROAD, NOW A COUNTY ROAD, THIRTY-SIX (36) RODS TO A POINT ON THE SOUTH LINE OF SAID SECTION SIX (6), WHICH POINT IS ONE HUNDRED ONE (101) RODS AND SIX (6) FEET WEST OF THE SOUTHEAST CORNER OF THE SOUTHWEST QUARTER OF SECTION SIX (6), THENCE EAST ALONG THE SOUTH LINE OF SAID SECTION SIX (6) ONE HUNDRED ONE RODS AND SIX (6) FEET TO THE PLACE OF BEGINNING, CONTAINING 12-7/8 ACRES MORE OR LESS
