Lot one (1), Two (2) and Three (3), the same being One Hundred (100) feet by One Hundred Forty-three (143) feet in the Southeast corner of Block Two (2) of Rose Lawn Addition to the Town of Stevenson, according to the official plat thereof now on file and of record in the office of the Auditor of said Skamania County, State of Washington.
