ROBERT L. FOWLER ET UX TO E. J. MILLER

KNOW ALL MEN BY THESE PRESENTS, THAT, WHEREAS, ROBERT L. FOWLER, AS OWNER OF LOTS 4 AND 5 OF OREGON LUMBER COMPANY'S SUBDIVISION OF SECTION 14 Tp 3 N R 9 E. W.M., BEING $S\frac{1}{2}$ $SE\frac{1}{4}$ $NW\frac{1}{4}$ AND $N\frac{1}{2}$ $NE\frac{1}{4}$ $SW\frac{1}{4}$, SECTION 14, RESPECTIVELY, DID ON OR ABOUT THE 9TH DAY OF JUNE 1908 POST TWO CERTAIN NOTICES OF CLAIM OF WATER RIGHT UPON A CERTAIN STREAM IN THE VICINITY OF SAID LAND, WHICH SAID WATER RIGHT NOTICES WERE THEREAFTER RECORDED IN THE OFFICE OF THE AUDITOR OF SKAMANIA COUNTY, WASHINGTON, AT PAGE 290 OF BOOK E. OF MISCELLANEOUS RECORDS, ON THE 17TH DAY OF JUNE 1908, AND WHEREAS, THE SAID ROBERT L. FOWLER, AND MILDRED FOWLER, HIS WIFE, DID THEREAFTER CONVEY THE SAID LOT 4 (BEING THE $S\frac{1}{2}$ $SE\frac{1}{4}$ $NW\frac{1}{4}$ SECTION 14 AFORESAID) TO E. J. MILLER, AND DID ALSO ASSIGN OR CONVEY TO THE SAID E. J. MILLER ONE OF THE ABOVE MENTIONED WATER RIGHTS INTENDING THEREBY TO CONVEY THAT CERTAIN WATER RIGHT APPURTENANT TO SAID LOT 4, BUT BY ERROR THE WATER RIGHT APPURTENANT TO AND FILED FOR USE UPON LOT 5 WAS DESCRIBED AND CONVEYED BY SAID INSTRUMENT.

NOW, THEREFORE, IN ORDER TO CORRECT SAID ERROR, AND IN CONSIDERATION OF THE MUTUAL BENEFITS TO THE PARTIES HERETO, THE SAID ROBERT L. FOWLER AND MILDRED FOWLER, HUSBAND AND WIFE, PARTIES OF THE FIRST PART, DO HEREBY CONVEY AND QUIT-CLAIM UNTO THE SAID E. J. MILLER, THAT CERTAIN WATER RIGHT DESCRIBED IN NOTICE POSTED ON THE 9TH DAY OF JUNE 1908, AND RECORDED ON THE 17TH DAY OF JUNE 1908 AT PAGE 290 OF BOOK E. OF MISCELLANEOUS RECORDS OF SKAMANIA COUNTY, WASHINGTON, IN WORDS AND FIGURES AS FOLLOWS, TO-WIT: "THE UNDERSIGNED CLAIMS THE WATER FLOWING IN THIS STREAM TO THE EXTENT OF ONE CUBIC ^{FOOT} OF WATER PER SECOND OF TIME. I CLAIM THE WATER FOR DOMESTIC USE AND IRRIGATION AND I INTEND TO USE IT AT $S\frac{1}{2}$ OF $SE\frac{1}{4}$ OF $NW\frac{1}{4}$ OF SEC 14 Tp 3 N R 9 EAST OF W.M. I INTEND TO DIVERT THE WATER AT A POINT 366 FEET SOUTH OF SW CORNER OF $SE\frac{1}{4}$ OF $NW\frac{1}{4}$ OF SEC 14 Tp 3 N R 9 EAST OF W.M., BY MEANS OF DITCH OR FLUME. NOTICE
