THIS INDENTURE, MADE THIS 21ST DAY OF APRIL 1925 BY AND BETWEEN W. A. ARNOLD, PARTY OF THE FIRST PART AND FANNIE A. ARNOLD, HIS WIFE, PARTY OF THE SECOND PART, WITNESSETH;

THAT THE SAID PARTY OF THE FIRST PART, FOR AND IN CONSIDERATION OF THE SUM OF ONE DOLLAR TO HIM IN HAND PAID, THE RECEIPT WHEREOF IS HEREBY ACKNOWLEDGED, DOES BY THESE PRESENTS REMISE, RELEASE AND FOREVER QUITCLAIM UNTO THE SAID FANNIE A. ARNOLD, HER HEIRS AND ASSIGNS, THE FOLLOWING DESCRIBED REAL PROPERTY, SITUATE, LYING AND BEING IN THE COUNTY OF SKAMANIA, STATE OF WASHINGTON, TO-WIT:

1. COMMENCING AT A POINT 542.2 FEET SOUTH OF A ROCK MARKING THE INTERSECTION OF THE SHEPARD D.L.C. AND THE NORTH LINE OF SEC. 1 Tp. 2 NORTH OF RANGE 7 EAST OF W.M., SAID POINT BEING ON THE NORTH LINE OF SECOND STREET, WHICH IS ALSO THE NORTH LINE OF STATE ROAD NO. 8, THENCE WEST 684 FEET TO THE PLACE OF BEGINNING OF THE TRACT HEREBY CONVEYED; THENCE NORTH 100 FEET; THENCE WEST 75 FEET, THENCE SOUTH 100 FEET TO THE NORTH LINE OF SECOND STREET, THENCE EAST 75 FEET TO THE PLACE OF BEGINNING, BEING THE SAME PROPERTY DESCRIBED IN THAT CERTAIN MORTGAGE DATED JANUARY 19, 1921 AND RECORDED AT PAGE 454 BOOK O'OF MORTGAGES, RECORDS OF SKAMANIA COUNTY, WASHINGTON.
