THIS INDENTURE. MADE THIS 20TH DAY OF APRIL IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND 25, BETWEEN R. H. BUNKER AND ORIA BUNKER, HIS WIFE, OF THE COUNTY OF CLARK AND STATE OF WASHINGTON PARTIES OF THE FIRST PART, AND JAMES F. WALSH OF THE COUNTY OF MULTNOMAH AND STATE OF OREGON PARTY OF THE SECOND PART, WITNESSETH, THAT THE SAID PARTIES OF THE FIRST PART, IN CONSIDERATION OF THE SUM OF TWO HUNDRED DOLLARS, TO THEM IN HAND PAID BY THE SAID PARTY OF THE SECOND PART, THE RECEIPT WHEREOF IS HEREBY ACKNOWLEDGED, DO HEREBY GRANT, BARGAIN, SELL AND CONVEY UNTO THE SAID PARTY OF THE SECOND PART, HIS HEIRS, EXECUTORS AND ASSIGNS, FOREVER, ALL TIMBER, LYING, STANDING OR BEING UPON ALL THOSE TRACTS OR PARCELS OF LAND LYING AND BEING IN THE COUNTY OF SKAMANIA AND STATE OF WASHINGTON DESCRIBED AS FOLLOWS, TO-WIT:

THAT PART OF THE SOUTH HALF OF THE SOUTHWEST QUARTER ( $S\frac{1}{2}$  OF  $SW\frac{1}{4}$ ) SECTION FOURTEEN (14) WEST AND SOUTH OF THE STATE HIGHWAY, AND NORTH HALF OF NORTHWEST QUARTER ( $N\frac{1}{2}$  OF  $NW\frac{1}{4}$ ) SECTION TWENTY THREE (23) OF TOWNSHIP THREE (3) NORTH OF RANGE NINE (9) EAST OF THE WILLAMETTE MERIDIAN. (IT IS UNDERSTOOD THAT THERE IS NO TIMBER UPON THE LAND IN SECTION FOURTEEN ABOVE DESCRIBED, BUT PERMISSION IS GIVEN HEREBY TO OCCUPY AND CROSS THE SAME WITH TIMBER LOGS AND OTHER MATERIAL CUT FROM ABOVE LANDS AND OTHER LANDS BELONGING TO OR SUBSEQUENTLY ACQUIRED BY SECOND PARTY HERETO), TOGETHER WITH THE RIGHT TO ENTER UPON SAID LAND AND CUT AND REMOVE THEREFROM AT ANY TIME WITHIN FIVE (5) YEARS FROM DATE HEREOF THE TIMBER HEREIN CONVEYED, HEREBY GRANTING THE RIGHT TO CUT SUCH TIMBER AND MAKE SUCH OTHER ALTERATIONS ON SAID LAND AS MAY BE REQUIRED IN THE CUTTING AND REMOVAL OF SAID TIMBER AND REMOVING SUCH OTHER TIMBER AS SECOND PARTY OWNS OR ACQUIRES OVER AND ACROSS THE SAME.

TO HAVE AND TO HOLD THE SAME, TO THE SAID PARTY OF THE SECOND PART HIS HEIRS, EXECUTORS AND ASSIGNS, FOR AND DURING THE TERM AFORESAID, WITH THE RIGHT OF OCCUPANCY OF SAID LANDS, AND SAID PARTIES OF THE FIRST PART, FOR THEMSELVES
