COMMENCING AT THE NW CORNER OF THE S $\frac{1}{2}$ OF NE $\frac{1}{4}$ OF SW $\frac{1}{4}$ OF SECTION 17 Tp. 3 N. R. 8 EAST OF W. M., THENCE EAST 21 RODS, THENCE SOUTH 38 RODS, THENCE WEST 21 RODS, THENCE NORTH 38 RODS TO THE POINT OF BEGINNING.
