M. HOUTS OF CLARKE COUNTY, WASHINGTON, THE RECEIPT WHEREOF IS HEREBY ACKNOWLEDGED, DO HEREBY RELEASE AND FOREVER QUIT CLAIM UNTO THE SAID E. M. HOUTS, AND UNTO THEIR HEIRS AND ASSIGNS ALL OUR RIGHTS TITLES AND INTEREST IN AND TO THE FOLLOWING DESCRIBED PREMISES, NAMELY: THE NORTHWEST QUARTER OF THE NORTHWEST QUARTER OF SECTION TWO (2), TOWNSHIP ONE (1) NORTH OF RANGE FIVE (5) EAST OF THE WILLAMETTE MERIDIAN IN SKAMANIA COUNTY, STATE OF WASHINGTON. EXCEPT AN UNDIVIDED ONE HALF INTEREST OF ALL THE WATER THAT FLOWS FROM A SPRING LOCATED UPON SAID TRACT OF LAND AS RESERVED BY JAMES H. MILLER ET UX SAID SPRING BEING LOCATED ON THE SOUTHEAST PART OF SAID TRACT OF LAND AND THE WATER CROSSING THE SOUTH BOUNDARY OF SAID TRACT. EIGHT (8) CHAINS WEST FROM THE SOUTHEAST CORNER OF SAID FORTY (40) ACRES OF LAND IT BEING UNDERSTOOD THAT JAMES H.
