R. V. Carpenter et ux to Edna Mintzer

This Indenture, Made this 4th day of January in the year of our Lord one thousand nine hundred and thirty-nine between R. V. Carpenter and Anna Carpenter, husband and wife, parties of the first part, and Edna Mintzer party of the second part:

Witnesseth, That the said parties of the first part, for and in consideration of the sum of One Thousand and 00/100 Dollars, lawful money of the United States, to them in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, do by these presents Grant, Bargain, Sell, Convey and Warrant unto the said party of the second part, and to her heirs and assigns, the following described tract or parcel of land, lying and being in the County of Skamania and State of Washington, and particularly bounded and described as follows, to-wit:

Beginning at the Northwest corner of the George W. Johnson Donation Land Claim No. 39 in Section Twenty (20), Township Two (2) North, Range Seven (7) East, Willamette Meridian; running thence South seventeen (17) degrees thirty (30) minutes East 2327.16 feet to a point on the North bank of a slough; thence north seventy-six (76) deg. eighteen (18) minutes East 81 feet; thence North eighty (80) deg. twenty-three (23) minutes East 133 feet; thence North eighty-four (84) deg. six (6) minutes East 177 feet; thence North seventy-seven (77) deg. eight (8) minutes East 357 feet; thence North seventy-one (71) deg. twenty-two (22) minutes East 339 feet; thence East 220 feet; thence North 2220 feet to a point on the Northern boundary line of the said George W. Johnson Donation Land Claim; thence south eighty-three (83) deg. 00 minutes West 1983 feet to the point
