

TO BE CONSTRUCTED ACROSS THE COLUMBIA RIVER AT SAID POINT OVER AND ACROSS THAT PORTION OF THE DANIEL F. BRADFORD AND CHLOE H. BRADFORD DONATION LAND CLAIM IN SKAMANIA COUNTY, WASHINGTON, LYING BETWEEN THE RIGHT-OF-WAY OF THE SPOKANE, PORTLAND AND SEATTLE RAILWAY COMPANY AND THE PUBLIC HIGHWAY KNOWN AS THE NORTH BANK HIGHWAY, THE CENTER LINE OF SAID PROPOSED BRIDGE BEING DESCRIBED AS FOLLOWS, TO-WIT: BEGINNING AT A POINT ON THE SECTION LINE BETWEEN SECTIONS TWELVE (12) AND THIRTEEN (13) IN TOWNSHIP TWO (2) NORTH OF RANGE SEVEN (7) EAST OF THE WILLAMETTE MERIDIAN IN HOOD RIVER COUNTY, OREGON, 4285.6 FEET WEST OF THE SOUTHEAST CORNER OF SAID SECTION TWELVE (12) IN TOWNSHIP TWO (2) NORTH OF RANGE SEVEN (7) EAST OF THE WILLAMETTE MERIDIAN; WHENCE EXTENDING IN A STRAIGHT LINE BEARING NORTH 76° 44' WEST CROSSING THE COLUMBIA RIVER INTO SKAMANIA COUNTY, WASHINGTON, AND CROSSING THE SHORELAND AND BRADFORD'S DONATION LAND CLAIM TO AN INTERSECTION WITH THE SAID PUBLIC HIGHWAY, TOGETHER WITH ALL AND SINGULAR, THE TENEMENTS, HEREDITAMENTS AND APPURTENANCES THERE-UNTO BELONGING OR IN ANYWISE APPERTAINING; AND THE REVERSION AND REVERSIONS, REMAINDER AND REMAINDERS, RENTS, ISSUES AND PROFITS THEREOF.

TO HAVE AND TO HOLD, ALL AND SINGULAR, THE PROPERTY RIGHTS AND FRANCHISE AND ESTATE HEREINBEFORE DESCRIBED INTENDED TO BE CONVEYED TO THE SAID PARTY OF THE SECOND PART, ITS SUCCESSORS AND ASSIGNS FOREVER; AND THE SAID PARTIES OF THE FIRST PART COVENANT UNTO THE SAID PARTY OF THE SECOND PART THAT THEY ARE LAWFULLY SEISED AND POSSESSED OF SAID LANDS AND PREMISES WITH RIGHT AND LAWFUL AUTHORITY TO SELL AND CONVEY THE SAME IN THE MANNER AND FORM AFORESAID, AND THAT THEY SHALL AND WILL WARRANT AND DEFEND THE TITLE TO ALL AND SINGULAR THE SAID PROPERTY BY THEM HEREBY CONVEYED, AGAINST ANY AND ALL CLAIMING OR TO CLAIM THE SAME BY, THROUGH OR UNDER THEM OR EITHER OF THEM.

IN WITNESS WHEREOF, THE SAID PARTIES OF THE FIRST PART, THE BRIDGE OF THE GODS CORPORATION AND THE INTER-STATE CONSTRUCTION CORPORATION, HAVE CAUSED THESE PRESENTS TO BE EXECUTED, AND THEIR RESPECTIVE CORPORATION NAMES HAVE BEEN BY THEIR RESPECTIVE PRESIDENTS AND SECRETARIES HERETO ATTACHED, AND HAVE CAUSED THEIR RESPECTIVE CORPORATE SEALS TO BE HERETO AFFIXED AS OF THE 1ST DAY OF OCTOBER, 1925.
