KNOW ALL MEN BY THESE PRESENTS, THAT C. O. WILLIAMS AND AMANDA E. WILLIAMS,
HIS WIFE, OF THE COUNTY OF SKAMANIA, IN THE STATE OF WASHINGTON, IN CONSIDERATION OF THE
THE BENEFITS AND OTHER VALUABLE CONSIDERATIONS, AND THE SUM OF THREE HUNDRED DOLLARS, IN HAND
PAID, RECEIPT WHEREOF IS HEREBY ACKNOWLEDGED, HAVE GRANTED, BARGAINED, SOLD AND
CONVEYED, AND BY THESE PRESENTS DO GRANT, BARGAIN, SELL AND CONVEY UNTO THE STATE
OF WASHINGTON THE FOLLOWING DESCRIBED PARCELOF LAND SITUATED IN SKAMANIA COUNTY,
WASHINGTON, TO-WIT:

A STRIP OF LAND 100 FEET WIDE, BEING 50 FEET ON EACH SIDE OF THE CENTER
LINE OF SAID ROAD AS SURVEYED OVER AND ACROSS $E\frac{1}{2}$ OF $SW\frac{1}{4}$ OF $SE\frac{1}{4}$ AND $SE\frac{1}{4}$ OF $SE\frac{1}{4}$
EXCEPT AS FOLLOWS: FROM STATION 768+33 TO 784+10.8 AND FROM STATION 173+83.4 (SKA-
MANIA WEST- TO 171 RIGHT OF WAY TO BE 100 FEET WIDE AND FROM STATION 171 TO 169+25
RIGHT OF WAY TO BE 70 FEET WIDE, ON SOUTH SIDE OF CENTER LINE OF SAID ROAD; AND
FROM STATION 169+25 TO 170, ALSO FROM STATION 172+40 (SKAMANIA WEST) TO 173+83.4 AND
FROM STATION 78.4+10.8 TO 771 RIGHT OF WAY TO BE 70 FEET WIDE AND FROM STATION
170 TO 172+40 (SKAMANIA WEST) SAID RIGHT OF WAY TO BE 100 FEET WIDE ON THE NORTH
SIDE OF THE CENTER LINE OF SAID ROAD.

IT IS FURTHER AGREED THAT GRANTORS HEREIN SHALL AND DO HEREBY WAIVE ALL
RIGHT TO AN UNDER ROAD STOCK PASSAND ALSO WAIVES ALL PRESENT AND FUTURE CLAIMS FOR
DAMAGES RESULTING FROM THE DESTRUCTION OF THE OLD COUNTY ROAD AT OR NEAR THE FOOT
OF SLOPE ALONG SOUTH SIDE OF PRESENT STATE ROAD, AND IN FURTHER AND ADDITIONAL
CONSIDERATION FOR THE ABOVE THE GRANTEE HEREIN AGREES TO TILE THE SPRING AT OR NEAR
STATION 780 TO THE EDGE OF FILL ON SOUTH SIDE OF SAID ROAD, AND TO RECONSTRUCT OR
REPAIR ALL DAMAGE CAUSED AT THE TIME OF CONSTRUCTION. OF THE NEW STATE ROAD LOCATED:
AS ABOVE DESCRIBED TO THE PRESENT COUNTY ROAD WHICH LEADS TO THE NORTH FROM
PRESENT STATE ROAD AT OR NEAR STATION 170 (SKAMANIA WEST).
