COMMENCING AT THE $\frac{1}{4}$ CORNER ON THE EAST SIDE OF SECTION 36, TWP. 3 N. R. $7\frac{1}{2}$ E. W.M., AND RUNNING S. $0^{\circ} 08' W.$, 127.1 FEET TO AN INTERSECTION WITH THE CENTERLINE OF THE SAID STATE ROAD No. 8 (NORTH BANK HIGHWAY); THENCE TURNING AN ANGLE OF $60^{\circ} 36'$ TO THE RIGHT AND RUNNING S. $60^{\circ} 44' W.$, 274.6 FEET; THENCE ON THE ARC OF A CURVE TO THE LEFT, HAVING A RADIUS OF 955.0 FEET A DISTANCE OF 323.1 FEET; THENCE TURNING AN ANGLE OF $180^{\circ} 00'$ TO THE RIGHT FROM A LINE TANGENT TO THE ARC OF SAID CURVE, TO A LINE TANGENT TO THE ARC OF ^A CURVE; THENCE ON THE ARC OF A CURVE TO THE LEFT, HAVING A RADIUS OF 50.0 FEET A DISTANCE OF 77.3 FEET TO AN INTERSECTION WITH THE NORTH-WESTERLY RIGHT OF WAY LINE OF THE SAID STATE ROAD No. 8 (NORTH BANK HIGHWAY) AND THE TRUE POINT OF BEGINNING OF THE REQUIRED STRIP OF LAND.
